

difficult, because they get tired of working, because of difficulties with other employees, because they move to a different locality, or for other reasons. But in getting a job, which depends upon the belief of the employer (tenth) in the ability (reputation) of the employee to fill the job, the tenth house seems to be more important than the sixth.

Yet as either getting a job or losing it involves not only the position itself but the labor associated with it, normally there must be unusual activity of the thought-cells mapped by the tenth house and unusual activity of the thought-cells mapped by the sixth house, such as is only present when they acquire additional energy from a progressed aspect to the rulers of the tenth and sixth.

If a job is a bad one, or one in which the salary is inadequate, it may be fortunate when the individual quits it and starts looking for other employment. On the other hand, it is likely that some of the 19 persons who had only a harmonious progressed aspect to the ruler of the tenth, some of the 17 persons who had only a harmonious progressed aspect to the ruler of the sixth, and some of the 9 persons who had harmonious progressed aspects dominant, at the time they lost their jobs, had birth-chart thought-cells which under later conditioning so strongly desired to Demonstrate idleness that the energy of any progressed aspect, however favorable, would enable them to bring about the loss of employment.

The data for the charts on getting employment and on losing it were tabulated in 1934, and include those who obtained or lost jobs during the boom year of 1929 and those who gained or lost jobs in the depression years that immediately followed. It took a lot more sixth and tenth house thought-cell activity in 1933 to get a job, and a lot less sixth and tenth house thought-cell activity to lose a job, than it did in 1929.

Right now (1942) when help cannot be obtained to harvest the crops, to run the streetcars, or to handle store and restaurant trade, due to the manpower being mobilized in the war effort, it takes far less sixth and tenth house thought-cell activity to get a job, and far more sixth and tenth house thought-cell activity to lose a job, than it did in 1938 when, according to Government reports, there were over 12 million persons seeking work who could not get employment. While we have no statistics to indicate the degree of difference, observation of the progressed aspects in many charts of those seeking, those getting, and those losing

employment during those years was convincing that it took a much more powerful progressed aspect in some years than in others to bring about comparable results. The same progressed aspect that in 1942 is almost a sure indication of getting a job at high wages, in 1938 was almost as sure an indication to one employed that he would be told his services were ended because there was not enough business to pay wages.

While people do lose jobs when the predominant progressed aspects are harmonious, and while the progressed aspects to the rulers of the sixth and tenth are harmonious, they are far more apt to lose a job they wish to keep when the predominant progressed aspects or those to the ruler of the tenth or to the ruler of the sixth are discordant. When there is a discordant progressed aspect to the ruler of the sixth, difficulties relative to the work nearly always crop up. And even when the progressed aspect to the sixth is slightly harmonious, if there is a heavy discordant progressed aspect acting as a Rallying Force, it is apt to cause difficulties in various ways including the work. Such progressed aspects, if the birth-chart shows the basic inclination, indicate a predisposition toward loss of employment.

*Precautionary Actions*—In some instances loss of employment may be due to the enmity or jealousy of others, in which case the seventh house thought-cells or the twelfth house thought-cells are involved; to inability of the business to continue paying wages, in which case the tenth house thought-cells are at fault; or to inability to get along with the boss, in which case the Sun thought-cells are responsible. But usually the difficulty lies in giving satisfactory service, which means that the sixth house thought-cells do not try to keep the job, that the natural aptitudes have not been properly trained.

Square pegs in round holes, and children trained in vocations for which unsuited, and people working amid conditions that attract misfortune, are a sad and needless waste of human energy. For success in any job, natural aptitudes and lucky breaks are about equally important. One of the first precautionary actions, therefore, is for the individual to be sure he is in a job to which he is well suited. How to insure this is explained in ample detail in the book, *HOW TO SELECT A VOCATION*.

But even in the most suitable vocation he can have trouble in his work if his sixth house thought-cells continually desire to stir up difficulty. When a progressed aspect to the ruler of the sixth permits new planetary energy to reach them they will find

opportunity to bring trouble. And the most effective way to prevent such unpleasantness, and possible loss of employment through it, is to change the desires of the sixth house thought-cells so they will work energetically to bring success and fortune where work is concerned.

Disagreeable thoughts and feelings about the work, as soon as they are discerned entering consciousness, should be displaced by pleasant thoughts. These pleasant thoughts about the work should be the constructive thoughts of the type governed by the planet ruling the sixth house, or the constructive thoughts of the type governed by the planet which is its mental antidote.

Furthermore, as often as the work is thought about, these pleasant and constructive thoughts should be brought to mind and associated with it. And if at the time there is one harmonious progressed aspect operative, it should be tuned in on, so that the mood and feeling most of the time will be of its quality. Its harmonious energy, thus picked up, radio fashion, in large volume, will find its way over the aerial formed by the progressed aspect to the ruler of the sixth, to the sixth house thought-cells, and tend to make their desires more advantageous.

The tenth house thought-cells may also be given a treatment to give them more harmony, and if the Sun thought-cells are discordant, these may be given harmonious energy also through pleasant thoughts about the boss.

But in addition, intelligence should be exercised to devise a way of handling the work satisfactorily; for environment also is important. If the boss has some particular sore spot, there is no advantage in bumping against it. And it may be worth while to observe what the boss or employer especially desires in his employees. Some want to observe volume in the work done, some especially desire accuracy and thoroughness, and some have pet aversions that it is needless to stimulate.

#### FATHER, DEATH OF

The tables relative to the death of the father and mother were compiled at a time when as yet we had no special conviction as to whether the tenth house rules the father or the mother. In fact, it seemed to us that as Cancer, the mother sign, is the natural ruler of the fourth, the mother should be related to the fourth house and her husband indicated by the house across the chart, which is the tenth. However, as in each of the 100 charts analyzed for the death of the father there was a progressed aspect to the ruler of the fourth, as well as one to the ruler of the eighth, and as in each of the 100 charts analyzed for the death of the mother—as will be observed by consulting the heading, Death of Mother—there was a progressed aspect to the ruler of the tenth as well as a progressed aspect to the ruler of the eighth, we were forced to conclude the tenth rules the mother and the fourth the father. This finding has been borne out by much subsequent experience in which the mother or father has affected individuals' lives.

That the opposite house should show a progressed aspect to it in 65% of the charts is not surprising when it is considered that the death of the father usually profoundly affects the life of the mother, and the death of the mother usually pronouncedly affects the life of the father. In other words, if the other parent was still living, the progressed aspect involving the surviving parent is about what would be expected; for what affects the surviving parent profoundly often also has some influence upon the individual's life.

As tested out quite extensively in Church of Light classes—in which the chart of the individual with the progressed positions placed around the outside is viewed by the students, and without knowing to whom the chart belongs, or anything else about it, the class is asked to decide what event took place—at times it is impossible to decide which parent died without having the charts and progressed aspects of the parents. Too often there are heavy progressed afflictions to both the fourth and the tenth, as well as to the eighth; and one cannot decide merely because

the tenth or fourth is more heavily afflicted by the progressed aspect. The surviving parent may influence the individual's life more profoundly at this time than it is influenced by the death of the other parent. If only the tenth is influenced by a progressed aspect, the mother is indicated; and if only the fourth is influenced by a progressed aspect, the father is indicated. But in 65% of the cases considered there were progressed aspects to both the ruler of the tenth and the ruler of the fourth at the death of a parent. Not only so, but in 11% of the charts the affliction to the house ruling the parent who survived was more powerful than to the house ruling the parent who died. This indicates that often knowledge of the physical conditions of both parents, and knowledge of the progressed aspects operative in their charts, are required to indicate which one is predisposed in the direction of demise during a period when the predisposition is strongly shown in the individual's chart that he may lose a parent.

*Precautionary Actions*—Of course, the fourth-house thought-cell activity inaugurated by a progressed aspect involving its ruler may exert its extra-physical power to attract an event into the life affecting crops on the ground, mining, real estate, or the home, rather than the father. This must be determined by the conditioning since birth, and by the environment. And if the events relating to these matters, and to the conditions at the end of life, are to be made more fortunate, the fourth-house thought-cells must be given more harmonious desires.

But after eliminating other departments of life that might be influenced by the progressed aspects, and concluding that the most probable event is mapped by the fourth house and the eighth house, and deciding from the physical condition or the progressed aspects in his chart that the father will be in danger, the precautionary actions may be made quite specific.

The first thing to realize in this connection is that the thought of death should not be associated with the father more often or more strongly than is necessary merely to recognize the predisposition; for the mental image itself has extra-physical power, and if given vitality often may work toward bringing about the anticipated event.

The next step is to use whatever influence one can to cause the father to take special care of his health. If he can be induced to eat as STELLAR DIETETICS indicate he should, and if he can be persuaded to cultivate the thoughts that are recommended in these pages for the progressed aspects operative in his chart,

it will greatly improve his prospects. But if he cannot thus be persuaded to look after his own health, he can be given mental treatments of the thought-type he specially needs to condition his thought-cells to have more harmonious desires, and he can be held often in the image of perfect health.

The individual who thus thinks of his father can also pleasantly associate trains of thinking which express the constructive qualities of the planet ruling the fourth house with thoughts about the home and the father. Or if these are difficult to hold without stirring up discordant emotion, pleasant thoughts which express the constructive qualities of the planet which is the mental antidote of the planet ruling the fourth may be used. And these thoughts should always be substituted with vigor whenever discordant thoughts relative to the father, or thoughts of his possible death, start to seep into the consciousness.

Most people could have a far happier home if they would take the pains to train their fourth-house thought-cells to have more harmonious desires. This they could do by selecting two sets of pleasant thought trains. One would have for its purpose the reconditioning of the thought-cells which most frequently stir up discord in the home. The thought-cells thus at fault could be determined as to their planetary type by observing what causes most of the home difficulties. That is, if Mars is heavily afflicted in the chart of birth, its thought-cells may have formed habit-systems of expressing that cause strife, not only in the home, but elsewhere. And it is not necessary under such circumstances that Mars make any aspect to the ruler of the fourth. By substituting pleasant thoughts of initiative or construction, or by substituting the mental antidotes which are pleasant thoughts of protecting the weak and helpless, for other Mars thinking, these Mars thought-cells can be reconditioned to desire more fortunate events.

The other type of thinking should be cultivated relative to the home. It should embrace the thoughts which express the constructive qualities of the planet ruling the home, or embrace the thoughts which express the constructive qualities of this planet's mental antidote. And this train of thought, which should be charged with pleasant memories or pleasant desires, should be immediately brought to mind and cultivated whenever discord in the home starts, or whenever thoughts start to enter the mind relative to such difficulties. This will change the desires of the thought-cells mapped by the fourth house, and they will then be able to bring fortunate events relative to the home into

the life whenever the ruler of the fourth is involved in a progressed aspect.

### FRIENDS, BENEFIT THROUGH

While this analysis covers only the times when a friend in some manner benefited the individual, charts progressed to the time a friend injured or otherwise influenced the individual indicate that the actions of friends bring events of consequence into the life only at those times when there is a progressed aspect involving the ruler of the eleventh house.

The hopes and wishes of the individual are his mental friends, and the thought-cells mapped by the eleventh house of his chart of birth have been organized not only by experiences relative to close associations with others, but also by those having to do with the realization of desires in general. Thus in human life their power and harmony or discord are an indication, not so much of his success but of his ability to realize his hopes. These hopes may be very high, or they may be quite modest. They may relate to any department of life. But a progressed aspect giving them harmonious energy gives them power to aid in the realization of these hopes; more commonly through the influence of friends.

In this world we do not lead isolated lives; all are interdependent. And to get what we wish out of life often requires that others use their good offices in our behalf. And they do this in a significant manner only at those times when a progressed aspect to the ruler of the eleventh house gives the thought-cells thus mapped additional extra-physical power.

Now people may work privately to bring about things beneficial to the individual, or they may work privately to bring about things detrimental to the individual. The thought-cells of the twelfth house are those that work to cause people to strive privately to thwart the individual's hopes and wishes. If they are unusually active you may be sure that he will have many

private enemies, and that his life will hold many disappointments. A chart with several planets in the twelfth house indicates the failure on many occasions to realize the hopes and wishes; usually through the influence of other people.

The eleventh house and the twelfth house need to be distinguished from the seventh house in that the seventh house represents those who openly stand before the public in favor of the individual or opposed to him. That is, in a manner they identify themselves as partners with him, or as open opponents. But the eleventh house persons and the twelfth house persons may or may not publicly proclaim their desire to help or hinder; but they do exert their influence in various private ways either to help him or to thwart him; those ruled by the eleventh working to assist, and those ruled by the twelfth working to hinder.

An individual with a heavily afflicted eleventh house may not hold his friends. They may become enemies, and then are influenced by the action of his twelfth house thought-cells. Or they may remain friends, and because of their influence on his life they may injure him. They may give him bad advice, they may cause him to follow unwise courses of conduct, or their own conduct may reflect upon his character and fortune.

In these 100 charts analyzed some were benefited in each of the various departments of life, and in each instance, in addition to the progressed aspect to the ruler of the eleventh, there was also a progressed aspect to the ruler of the house governing the department of life from which the benefit came. If the benefit was financial, there was also a progressed aspect to the ruler of the second; if the benefit was gaining a position, political or otherwise, there was also a progressed aspect to the ruler of the tenth; if the benefit related to pleasures, there was also a progressed aspect to the ruler of the fifth; if the benefit was an opportunity for a short trip, there was also a progressed aspect to the ruler of the third; or if it helped the individual get something published, there was also a progressed aspect to the ruler of the ninth.

Some of the individuals received help from friends when the predominant progressed aspects were discordant. These heavy afflictions had attracted to them financial difficulties, illness, loss of job, or trouble with the law, and a friend or friends came forward and helped them out of the difficulty.

Usually when friends gave assistance was when there was at least one harmonious progressed aspect to the ruler of the eleventh house. However, there were some instances in which dominant



harmonious progressed aspects acted as Rallying Forces to give the eleventh house thought-cells harmonious energy even while the only progressed aspect to the eleventh was discordant, and a few instances in which the birth-chart thought-cells were so harmonious that they continued to desire and work for bringing benefits through friends even when the planetary energy received from the progressed aspects was discordant. But one can count much more certainly on friends giving a helping hand when both the predominant progressed aspects and the progressed aspect to the ruler of the eleventh are harmonious.

*Precautionary Actions*—If the help of friends is to be expected it goes without saying that the groundwork of friendships should be laid. This means that the individual must be interested in the problems of others, and be willing to give sympathy, help, understanding and companionship. He should not hesitate to spend time and effort to be of assistance to people, and he should never, under professed friendship, speak slightingly to others of his acquaintances, in the unconscious effort to bolster his own feeling of superiority. He should not only help others, but he should see to it that when he is with them they have a good time.

However, such environmental facilities are not sufficient to counteract the desires of thought-cells that strive to thwart helpfulness from friends. We all know people who are constantly helping others and giving them a good time, but who in return seem always to get merely ingratitude. People accept favors from them, but seldom lift a hand in their behalf. This is because the thought-cells mapped by the eleventh house are so discordant they work to cause others to take advantage of the individual's goodheartedness.

What must be done is to change the desires of these thought-cells. First the planet, or planets, ruling the eleventh house should be noted, and then thoughts should be selected and cultivated which are pleasant and at the same time express the constructive side of this planet's energy. Or if it is too difficult to feel pleasure in these thoughts, pleasant trains of thought expressing the constructive side of this planet's mental antidote should be selected and cultivated.

And to insure they build energy into the eleventh house thought-cells, these thoughts should be associated with, and revolve around, thoughts about friends and friendship. Whenever unpleasant thoughts of any kind about friends begin to seep into the mind, these happy and constructive thoughts about a friend—about some experience with a friend, or hoped for

experience with a friend—should be substituted. They should be given sufficient harmonious emotional energy that they dislodge the inharmonious thought.

When there is a progressed aspect to the ruler of the eleventh these precautionary actions should be given special attention, and unless the progressed aspects are quite adverse, contacts should be sought with those who might possibly provide benefits. If the progressed aspects are too adverse, it is better to place little confidence that assistance will be forthcoming. However, if at the same time there is one strong and harmonious progressed aspect operative in the chart, its energy may be tuned in on by holding thoughts and a mood typical of its vibrations. To the extent this effort is successful will its energy reach all the thought-cells involved in progressed aspects at the time, and tend thus to give the eleventh house thought-cells harmonious desires instead of those that would have been stimulated by the progressed aspect to the ruler of the eleventh.

### HONOR, ATTAINMENT OF

This table indicates it is quite difficult to get favorable recognition or to attain a political position when there is only a progressed affliction to the ruler of the tenth, and highly unlikely any honor will be attained during those times there is no progressed aspect to the ruler of the tenth. As will be observed by consulting the analysis on getting employment, people secure a position to work about one third of the time when the only progressed aspect to the ruler of the tenth is discordant. But to get favorable public recognition usually there must be at least one harmonious progressed aspect to the ruler of the tenth.

The Sun is the ruler both of significance and those in places

of authority who often must be relied on to confer the honor. In cases of gaining a position through popular election, aside from the Sun ruling those who have authority, it is the planet of politics. And in attaining any honor it seems, from these tables, to be quite as important as the tenth house. Thus even as Mars may rightly be considered the planet of accident, and Neptune the planet of poisoning, we are justified in considering the Sun as the planet of honors.

However, in thus considering these planets it must not be lost sight of that always in addition to a progressed aspect to the planet, there must be a progressed aspect involving one or more specific house. For honor to be attracted there must be not only a progressed aspect to the Sun, but also a progressed aspect to the ruler of the tenth; for accident to be attracted there must be not only a progressed aspect to Mars, but also a progressed aspect to the ruler of the first house; and for the individual to be poisoned, there must be not only a progressed aspect to Neptune, but also a progressed aspect to the ruler of the first house and a progressed aspect to the ruler of the sixth house.

People get honors more often when the only progressed aspect to the Sun is harmonious than they do when the only progressed aspect to the tenth is harmonious. But a discordant progressed aspect to the Sun is not nearly so thwarting in reference to gaining honors as a discordant progressed aspect to the ruler of the tenth. Honors are attained with more difficulty when there are both harmonious and discordant progressed aspects to both the Sun and the ruler of the tenth, than when these two receive only harmonious progressed aspects. But the obstacles when thus aspected are usually not too high to be surmounted, especially if at the time the predominant influence in the chart, which may be used as a Rallying Force, is a harmonious progressed aspect.

In considering the activity and the harmony or discord of the thought-cells mapped by the tenth house, the degree occupied by the birth-chart midheaven, and the degree occupied by the progressed M.C. are highly significant. Progressed aspects to and from the M.C. are highly potent, quite as much so as similar aspects between any of the planets, especially where credit and honor are concerned.

Both the thin blue line through the astral body marking the M.C. of the birth-chart, and the less distinct thin blue line through the astral body marking the major progressed M.C., act as amplifiers, by which astral energy is brought to a focus and widely

broadcast. And this broadcasting, whatever its nature may be, has a profound influence on the business, and on honors. If the thought-cells mapped by the tenth house feel happy, their broadcast is of a nature to assist the individual in his business or in attaining honors. But if these thought-cells feel discordant, either because they were organized that way before birth or because they receive discordant energy from a progressed aspect, their astral broadcast is of a nature to injure the individual in business and to bring him discredit.

Some people can do outrageous things and almost no one pays any attention to them. Another person with an afflicted tenth house is criticized for doing much less, and unjust rumors are spread about him. His tenth house thought-cells are so discordant that they work to bring him discredit to the extent they have energy, or gain it from a progressed aspect.

Those with an afflicted Sun tend to have difficulties with persons in authority; but if the Sun is powerful enough they may gain station and honors in spite of this. The Sun maps those thought-cells that relate to the drive for significance; and if these are active enough, even if discordant, the individual has a certain amount of power to gain and exercise authority. But if they are discordant he will attract no end of difficulty through the authority thus striven for or exercised.

*Precautionary Actions*—One essential of importance for attaining honors relates to sufficiently lowering the environmental resistance. Honors of minor importance may be attained through excellence in the work done; but those of real significance are attained only through some contribution to the welfare of men. That is, minor honors may relate to contributing to the advancement of some business or organization, but major honors relate to contributions to the welfare of society as a whole. They are not confined to any particular line of effort, but may be attained through any constructive work. The first precautionary action, therefore, is to accomplish some constructive work; and this is more easily done by selecting an activity for which the chart of birth—as set forth in the book, *HOW TO SELECT A VOCATION*—shows both special aptitude and considerable good luck.

But the accomplishment of something worthwhile for one's fellowman often fails to bring honor. If honor is to be attained, the accomplishment, whatever it may be, must be properly advertised. And usually if the individual tries to do the job of advertising himself, telling all and sundry how great an individual

he is, the attempt backfires and he is looked upon not with honor, but as a vain boaster.

What are really needed, in addition to worthwhile accomplishment, are active and harmonious tenth house thought-cells, and active and harmonious Sun thought-cells.

To thus recondition the tenth house thought-cells, select the thoughts which are the constructive expression of the planet ruling the tenth house, or if these have too painful associations, the thoughts which are the constructive expression of this planet's mental antidote; and cultivate these with as pleasant associations with thoughts about honors as it is possible to develop. Use them also to displace all discordant thoughts about credit and honor.

For better business success, use these thoughts as pleasantly associated with business as possible.

To recondition the Sun thought-cells, think strongly, pleasantly, and feelingly about authority, power and significance. And select the harmonious trains of thoughts ruled by the planet in the birth-chart which through aspect most favors the Sun; or if there is no good aspect to the Sun, select the harmonious trains of thought ruled by the best planet in the chart. Build these into the Sun thought-cells through thinking about them at the same time there are thoughts of significance, power and authority in the mind.

If there is, at the time progressed aspects formed to the ruler of the tenth and the Sun, also some harmonious progressed aspect operative, it may be tuned in on and used as a Rallying Force. Get into the mood of its harmonious vibrations. And it will be more effective if this mood is held while thinking of power, authority and honors.

#### HUSBAND OR WIFE, DEATH OF

Whenever the husband or wife affects the life of the individual through some important event there is always a major progressed aspect to the ruler of the seventh. And whenever the death of anyone affects the life of the individual importantly there is always a progressed aspect to the ruler of the eighth. But the

husband or wife does not always die when there is a progressed aspect to the ruler of the seventh and a progressed aspect to the ruler of the eighth, even when these progressed aspects are decidedly discordant. In fact, usually there are a number of periods in the individual's life during which there is both a progressed aspect to the ruler of the seventh and a progressed aspect to the ruler of the eighth.

Thus we cannot say from the progressed aspects in the individual's chart that during a certain period there is a predisposition for the husband or wife to die. The thought-cell activity may work for other events ruled by the seventh house and ruled by the eighth house. Thus the seventh house rules the public, and those with whom business more commonly is transacted. And a progressed affliction to the seventh may, if the environment and conditioning predispose in that direction, bring into the life some person who is not trustworthy, or who has poor judgment. And as the eighth house indicates the other person's money, the progressed affliction to the eighth house may indicate that this person becomes indebted to the individual, and cannot or will not pay the debt. Or it may mean that someone owing the individual money dies, and through the death he loses the amount of the debt.

On the other hand, even when the progressed affliction involving the seventh attracts a disagreeable experience through the husband or wife, this experience may not be death. It may be financial in nature; for the eighth house rules the partner's money, and this includes the partner by marriage. Thus the partner, or husband or wife, may make a bad financial investment, or lose money, and this loss affect the individual adversely.

To ascertain if, during the period when there is a progressed aspect to the ruler of the seventh and a progressed aspect to the ruler of the eighth, there is a predisposition toward the death of the husband or wife, the birth-chart and progressed aspects in the chart of the husband or wife should be consulted. This chart and its progressed aspects during the indicated period should then be studied with the aid of the tables and comments given under the heading, Death of Individual. Also the conditioning and environment of the husband or wife should be considered as giving facilities for, or offering resistance to, such an event.

But even should the chart of the husband or wife, during such a period, have heavy discordant progressed aspects, and progressed aspects to the ruler of the first and progressed aspects to the ruler of the eighth, this only shows a predisposition that under proper

environmental conditions may result in death. There is nothing inevitable about it. And if proper precautionary actions are taken it is likely that the death will not occur.

*Precautionary Actions*—When, from the birth-chart and progressed aspects in the individual's chart, and the birth-chart and progressed aspects in the marital partner's chart, the predisposition is indicated that the husband or wife may die during a certain period, the first precautionary action, other than recognizing that special steps should be taken, is to hold the image of the marital partner in perfect health and with abundant vitality in the mind whenever thoughts of him occur. Above all, do not hold the death thought over him, or have fear that he will die. Have the inner determination that he shall have health and live.

The next step should be to try to get the marital partner to live and think, during the period while the predisposition is present, in such a manner that the predisposition in his chart will find too much environmental and conditioned resistance to bring about his demise. For various reasons this may not be feasible. The marital partner may have opinions that cause him to reject all suggestions that he should live and think differently than he has done in the past. Or he may be following a calling in which the hazards of accident are high.

And while it is advisable to get him to think and eat in the manner STELLAR DIETETICS advises for the progressed aspects present in his chart, it is most inadvisable to present the matter to him in a manner that will arouse fear. It is a law of extra-sensory power that the unconscious mind tries to bring into reality whatever image is held before the attention. And thus if the marital partner causes him to fear he is going to die, it will tend, through the image thus implanted and held in his mind, toward bringing about that event. Not only so, but if the marital partner holds the image of fear, it will reach his unconscious mind as a suggestion, and thus will give him a mental treatment in the direction of death. But the image of perfect health, held by himself and held by the marital partner, will direct the energies of his unconscious mind toward this desired state.

The husband or wife, if possible, should be induced to cultivate trains of constructive thinking that will give more harmonious desires to the thought-cells mapped by the first house and to the thought-cells mapped by the eighth house.

But the individual in whose chart the predisposition shows of losing the husband or wife, needs to give more harmonious

desires to the thought-cells mapped by the seventh house, and to the thought-cells mapped by the eighth house.

To do this, the constructive thoughts belonging to the planet ruling the seventh should be selected, and associated as often as possible and as pleasantly as possible with all thoughts about the husband or wife. If the seventh house ruler is too heavily afflicted to make it feasible to think its constructive thoughts with enjoyment, the constructive thoughts ruled by the planet which is its mental antidote should frequently, and with emotional intensity, be pleasantly associated with thoughts of the marital partner. And these harmonious and constructive thoughts should be quickly substituted for any discordant thoughts about the husband or wife that tend to crowd into the mind.

It is not wise to think about death. But the eighth house thought-cells in general may be reconditioned to have more harmonious desires through thoughts about gifts and other people's money. To do this the constructive thoughts belonging to the planet ruling the eighth house should be selected and associated as often as possible and as pleasantly as possible with thoughts about the money of other people. If the eighth house ruler is too heavily afflicted to make it easy to think such pleasant thoughts, use instead the constructive thoughts which are the mental antidote of those ruled by the planet governing the eighth house. Cultivate such trains of thought, and associate them in the mind pleasantly with thoughts about other people's money.

Losses, by death or otherwise, come into the life only when there are progressed afflictions operative. It may be that the heavy affliction by progression at the time is neither from the ruler of the eighth nor the ruler of the seventh, but involving other planets. In this case it is well to recondition the thought-cells mapped by these planets, and to prevent their energies from acting as Rallying Forces through tuning in as constantly as possible in mood and feeling on whatever harmonious progressed energy may be present. Or if all the progressed aspects are afflictions, tune in on the vibrations of the best planet in the chart of birth.

That which stands out most importantly in these charts is the high degree of activity of the twelfth house in each birth-chart, and that at the time of imprisonment the progressed aspects are predominantly discordant. While most of the people whose charts were analyzed were imprisoned because of crimes, some were imprisoned because of political or religious ideals contrary to the ruling authority, and some because they were taken captive in time of war.

In the category of those imprisoned because of political activities are Eugene V. Debs, socialist nominee for U. S. President, who was imprisoned during 1918 and 1919, under progressed Saturn square birth-chart Moon, progressed Venus square progressed Jupiter, and progressed Sun semi-square progressed Venus, for his stand against war; Adolph Hitler, who was sent to prison April 1, 1924, under progressed Sun conjunction birth-chart Pluto and sesqui-square birth-chart Uranus, for attempting to start a revolution; Monsieur Daladier, one-time premier of France, who was imprisoned in 1941, under progressed Sun square Neptune, for opposing the Nazi conquerors; and Mahatma Gandhi, who was imprisoned in 1932, under progressed Sun conjunction birth-chart Saturn, in his campaign for the independence of India.

Whether Tom Mooney was guilty of bombing or not, he was working for organized labor, and political enemies were instrumental in placing him behind bars for 22 years under progressed Saturn opposition birth-chart Moon, progressed Ascendant opposition progressed Pluto, and progressed Sun sextile birth-chart Moon.

In each of these instances, and in the imprisonment of Joseph Smith, the Mormon leader on June 25, 1844, under progressed Sun semi-sextile Pluto, and progressed Saturn square birth-chart Ascendant, the influence of politics and those vested with political authority is indicated by the Sun being involved in the progressed aspect. And although he aroused prejudice through the unorthodoxy of his religious views, it was his flaunting of the duly established authorities which resulted in his imprisonment.

Although he escaped within a month, Winston Churchill was taken a prisoner of war on November 15, 1899, under progressed Jupiter opposition progressed Neptune, and progressed Sun semi-square birth-chart Mercury.

The lives and motives of these men are in violent contrast to those of such characters as gangster Al Capone, who was imprisoned in June, 1929, under progressed Ascendant sesqui-square Venus and progressed Pluto sesqui-square birth-chart Sun; Edward Hickman, who was later hanged for murder, who was imprisoned February 8, 1928, under progressed Mars square birth-chart Moon; and Albert Dyer who also later was hanged, who was imprisoned the last of June, 1937, for strangling to death three little girls, under progressed Mercury square birth-chart Mars.

But whether the imprisonment is due to martyrdom or to crime, the birth-chart always shows active twelfth house thought-cells. Except for nurses, doctors and detectives, active twelfth house thought-cells usually are detrimental to the fortune. While many who have active twelfth house thought-cells never are in danger of imprisonment, they do attract restrictions and disappointments and private enmities.

We do not have charts enough of those taken prisoners in war to determine if the ninth house is always involved, or even usually involved, in such imprisonment. But when court action is involved, or even the decision of some person in authority who thus represents the law, there is always a progressed aspect to the ruler of the ninth house. It takes unusual activity on the part of the thought-cells mapped by the ninth house to become involved with the law.

Neptune is the planet of involuntary servitude. It is the ruler of the twelfth house of a natural chart; and all the important events relative to the negro slaves of America took place when there were aspects in the cycle charts to Neptune. While a progressed aspect to Neptune alone will not place an individual in prison, a progressed affliction to Neptune commonly places some restrictions upon him; and if the other factors are present, increases the likelihood of imprisonment.

On its inversive side Pluto seems to be not merely the planet of gangsters, but the planet of crime in general. A progressed aspect to Pluto increases the likelihood of imprisonment which is indicated by the more constant factors.

But people do not become imprisoned while all their progressed aspects are harmonious. Very frequently a person commits a crime, and is either undetected or escapes during the time his progressed aspects are harmonious; only to be discovered or captured and imprisoned when heavy progressed afflictions

come along in his chart at the same time there is a progressed aspect to the ruler of the twelfth and a progressed aspect to the ruler of the ninth.

*Precautionary Actions*—Undoubtedly it is true that many people are walking the streets as respected citizens who are more deserving of imprisonment than many of those who are in jail. We may assume that the reason they have never been caught at crime is because they have more harmonious or less active twelfth house thought-cells than those who have been caught; for certainly some who escape deserved punishment have birth-charts which in general are as heavily afflicted as are the charts of many who are in prison.

Of course, one way to avoid being jailed is to create environmental resistance to such an event by always staying strictly within the law. But if you are in a country which is being despoiled by crooked politicians, perhaps your conscience will not permit you to remain within the unjust laws they have passed to protect them in their skuldugery. Or if you are serving your country's armed forces, it may be impossible to remain where there is no danger of capture.

What is needed most urgently is to give the twelfth house thought-cells more harmonious desires, and if favors of the court are to be gained, the ninth house thought-cells also should be given more harmonious desires.

In this work the constructive thoughts ruled by the planet governing the twelfth house should be associated often and pleasantly with thoughts of freedom. Or if the twelfth house ruler is too badly afflicted to make this possible, the constructive thoughts of the planet which is its mental antidote should frequently, and with emotional intensity, be pleasantly associated with thoughts about freedom.

For favors of the court, thoughts ruled by the planet governing the ninth house should be associated often and pleasantly with thoughts of court success. Or if the ninth house ruler is too badly afflicted to make this easy, the constructive thoughts of the planet which is its mental antidote should frequently, and with emotional intensity, be pleasantly associated with thoughts about success in the courts.

It must not be assumed that harmonious progressed aspects to the ruler of the twelfth, together with harmonious progressed aspects to the ruler of the ninth, will keep an individual out of jail. Many of those imprisoned whose charts were analyzed had

such favorable progressed aspects to these two houses. But at the same time they had other heavy progressed afflictions. These acted as Rallying Forces to give the thought-cells of these two houses discordant energy in spite of the harmonious progressed aspects to their rulers. This indicates that harmonious Rallying Forces should be utilized to give these thought-cells more favorable desires.

## JOURNEYS, LONG

What would be a long journey to one person might be a short journey to another. Those who sent us the data above tabulated considered the journeys long. The one in which a progressed aspect to the ruler of the ninth is missing, is one of three trips from New York to California and return taken by the same individual. At the time of the journey in question there were exceptionally powerful progressed aspects involving the ruler of the third, and progressed Moon was making an aspect to the ruler of the ninth. At the time of the other two trips, there were progressed aspects to the ruler of the ninth.

A progressed aspect to Mercury will not bring travel unless at the same time there is a progressed aspect to the ninth house or the third house; but when such an aspect to the ruler of travel is present, a progressed aspect to Mercury, and to a less degree a progressed aspect to Uranus, is an additional testimony of a journey.

A progressed aspect to Neptune will not bring a voyage unless at the same time there is a progressed aspect to the ruler of the ninth house; but when the ninth house ruler is aspected, Neptune, and to a less degree Jupiter, inclines toward the sea.

Before deciding that a progressed aspect to the ruler of the ninth predisposes toward a long journey, or a journey by sea, the birth-chart should be appraised in reference to the activity of the ninth house thought-cells, the past conditioning in reference to long journeys should be ascertained, and the probable influence of environment during the time the progressed aspect is perfect.

However active the ninth house thought-cells may be, as indicated by powerful aspects to the ruler of the ninth, or many

planets in the ninth, the individual may never take a long journey. The ninth house thought-cells may early in life so strongly get the habit of expressing their energy through publishing, through the practice of law, through religion, or through teaching or other public expression of opinions, that they invariably express through this particular channel whenever they gain new energy from a progressed aspect.

Or both the conditioning and the environment may so change that ninth house thought-cell activity at one period of the life may express exclusively through a long journey, and at another period may express through publishing, or teaching, or law.

For instance, in the writer's chart, progressed Sun, sole ruler of the ninth house, made the trine of birth-chart and progressed Neptune in 1908. Previous to that time there had been several long journeys, but nothing written for publication. Under this aspect a few short articles were published in astrological magazines. But while the aspect was operative, four long journeys were taken, including living six months on a little schooner.

Previous to 1937 I had been accustomed to take an automobile trip of some length during each summer vacation. Progressed Sun came to the square of progressed Neptune in August, 1937, and to the square of birth-chart Neptune in February, 1938. A number of new astrological magazines started about this time, and I was asked to write in each issue, in addition to several other astrological magazines I already regularly was writing for. Also the finances became available for publishing in book form several courses of B. of L. lessons which were already written. These were my most active years up to that date in getting material published; so active, in fact, that I could not be away from the city long enough to take my customary kind of vacation. As a consequence, I published more and traveled less during the time these aspects were operative than during any previous comparable period of my life.

This simply meant that during the years since 1908 my ninth house thought-cells had become so in the habit of expressing their energy through publishing that when a progressed aspect—dissimilar only in being less harmonious than the one in 1908—recurred between the same planets, instead of attracting a long journey, it attracted so much publishing that such a journey was precluded.

Now a progressed square tends to deliver energy to the thought-cells much more discordant than does a progressed trine; but between 1908 and 1938, both the ninth house thought-cells and

the sixth house thought-cells (Neptune is in the sixth) had become so much more favorably conditioned that I had less difficulty with health, and made more progress in various ways, in 1938 than in 1908. Thanks to taking proper precautionary actions.

The injection of a personal item is merely to illustrate a point. Had the conditioning been a bit different, the 1938 ninth house thought-cell activity might have expressed chiefly through teaching, or through preaching. As it was, I did about the same amount of both I had been doing for years; teaching two classes a week, and giving a religious talk now and then. But in 1908 I did no teaching and gave no religious talks.

If during these intervening 30 years I had taken up the practice of law, the progressed aspect might very well have expressed through handling one or more important legal cases.

*Precautionary Actions*—The tables here published give no indication as to the advantages or disadvantages the individuals derived from the long journeys tabulated. Sometimes such journeys are taken because the individual is going to make his home in a distant place. People from Europe in the past have thus crossed the Atlantic in great numbers to establish homes in America. But sometimes such journeys are taken for business reasons, sometimes for the educational advantages they bring, and sometimes merely for pleasure.

For whatever purpose taken, they may be more or less successful, they may be pleasant or accompanied by hardship, or they may be safe or lead to danger.

These factors are largely determined by the desires of the ninth house thought-cells. And these desires are apt more to be favorable to the individual when the predominant progressed aspects at the time are harmonious, and when the progressed aspect to the ruler of the ninth is harmonious. Then when it is possible to make a choice of the time to take such a trip, such progressed aspects should be selected.

But whether or not such selection is possible, the journeys or other ninth house events will be more pleasant and successful than they otherwise would have been, if the ninth house thought-cells are reconditioned to be more harmonious. To do this, select the thoughts which are the constructive expression of the planet ruling the ninth house, or if these have too painful associations, the thoughts which are the constructive expression of this planet's mental antidote; and cultivate these with as pleasant associations with thoughts about long journeys as possible. And use these

thoughts to displace all discordant thoughts that arise in reference to long journeys.

Should it be teaching or lecturing or preaching or publishing which it is desired to make more fortunate, the constructive thoughts indicated should be as often, and as pleasantly as possible, associated with thoughts of teaching or publishing or the other ninth house activity.

Then if at the time some progressed aspect forms to the ruler of the ninth there is a harmonious progressed aspect operative in the chart, through thought and mood characteristic of this harmonious progressed aspect, try to keep so tuned in on its energies that they will act as Rallying Forces to give the ninth house thought-cells so much harmonious energy that their desires will be influenced in the direction of such ninth house events that are highly fortunate.

### JOURNEYS, SHORT

What would be a short journey to some people would be a long journey to others. The journeys tabulated above were considered short by those who experienced them and sent the data to us. While progressed aspects to the travel planets, Mercury and Uranus, undoubtedly make travel more certain, yet the above table indicates that no prediction that a short journey is likely should ever be made from aspects to these planets alone; for unless at the same time there is a progressed aspect to the third, the individual will not take a trip of sufficient importance to consider it an important event.

On the other hand it should be pointed out that people do not take a short journey every time there is a progressed aspect to the ruler of the third house. In early years the third house thought-cells may have become conditioned so strongly toward expressing through events in which the relatives affect the life, through writing, or through studies, that each time they receive additional energy from a progressed aspect they desire, and work to bring about, an event of this particular type.

Take the chart of Earl Warren, who becomes governor of California in 1943. Here retrograde Uranus is only 6 minutes into the tenth house, and thus almost exactly conjunction the M.C. The Sun is in the third house, giving vitality to the third house

thought-cells, and is inconjunct aspect with Uranus and the M.C. By the time World War I was over, and he returned home after serving in the infantry, progressed Uranus had retrograded back to the inconjunct of birth-chart Sun. It was moving so slowly that this progressed aspect remains in force all the balance of his life, at all times giving his ninth house thought-cells and his third house thought-cells as much activity as those of most people have during the three years or less that the progressed Sun is inconjunct the ruler of the ninth or inconjunct the ruler of the third.

It might have been assumed that with so much third and ninth house thought-cell activity he would travel continuously. But, other than the oversea trip during World War I, he has seen no more travel than the average person. The reason is that the prominence (conjunction) aspect of Uranus with the place of honor (M.C.) in his chart of birth, and these two making a close aspect with the Sun, ruler of politics, gave him unbounded ambition, which he could serve best, not through roaming about, but by becoming familiar with the law (ninth house) and making a study (third) of criminal detection. Jupiter is ruler of the twelfth (criminals), and is closely trine with Uranus and the M.C.

The progressed aspects which have formed to the rulers of the third house—Sun and Neptune—during the past quarter century have seldom brought a trip of any kind. Instead they have had to do with his studies, including law and methods of police training and criminal identification. And this application to study and to acquiring ability as a prosecutor each time there were progressed aspects to both the Sun and Mars, the ruler of the tenth, made him deputy district attorney, chief deputy district attorney, district attorney, chairman of the State Board of Criminal Identification, president of the District Attorney's Association, chairman of the Advisory Board of California Institute of Technology School for Police Training, vice chairman-secretary on Criminal Law, attorney general of California, and now governor of California.

Instead of working to bring journeys, short or long, for a quarter of a century this man's third house thought-cells have worked ceaselessly to cause him to study and acquire the kind of information that would further his ambition for honors; and his ninth house thought-cells have worked as constantly to attract to him events relative to law enforcement which would enable him to put this knowledge into practice. That is, the third house and ninth house thought-cells became so conditioned that



they worked almost exclusively, each for a single type of event.

On the other hand there was O. O. McIntyre, who in 1937 was said to be the highest paid journalist in the world. He had Neptune, Pluto and Saturn in the ninth, and the Moon in the third in opposition to Neptune and Pluto, in sextile with Uranus, and square to the Sun. For a quarter of a century after the original trip from the Middle West to New York, he scarcely left the city. He never took what most people would call a long journey. But for twenty years his column, "New York Day by Day" appeared. And in addition to writing this column each day, he made excursions into writing articles for various magazines.

Progressed Pluto in the ninth house remained in opposition to birth-chart Moon throughout his life, giving him tremendous third and ninth house thought-cell activity. But an additional progressed aspect to one of the planets in the ninth that to another person would have caused him to circle the globe, merely brought McIntyre an assignment from some magazine to write another article; and the article, for which he was handsomely paid, was published. For a decade he dreamed and hoped to make the trip back to see his home town before he could tear himself from the metropolis long enough for this, to him, second momentous journey of his life.

Other people get equally involved with relatives, so that practically every progressed aspect to the ruler of the third brings an event due to some person of kin. Nevertheless, although the table indicates nothing of the advantages or disadvantages which arose from the journeys, it is quite clear that short journeys of any significance only occur when there is a progressed aspect to the ruler of the third.

*Precautionary Actions*—When it is possible to select the period during which a short journey is to be made, it is better to choose a time while the progressed aspects in the chart are predominantly harmonious, and also while the progressed aspect to the ruler of the third is harmonious. As Rallying Forces so commonly play an important part in influencing the desires of the thought-cells, it is better to have the progressed aspects operative in the chart predominantly harmonious than to have a harmonious progressed aspect to the ruler of the third and at the same time to have the progressed aspects predominantly discordant.

The success of the trip, and the obstacles encountered on it, are chiefly determined by the desires of the third house thought-cells. Or if the third house thought-cell activity expresses instead

through writing or study, the fortune or misfortune encountered, while influenced by the environment at the time, is chiefly determined by the desires of the third house thought-cells.

To have better fortune in any of these activities, therefore, the third house thought-cells should be given more harmonious desires. For this purpose trains of thought should be selected which are the constructive expression of the planet ruling the third house, or if these have been given too painful associations, the thoughts should be selected which are this planet's mental antidote; and these should be cultivated in as pleasant associations with thoughts of short journeys as possible, if the intent is to improve the luck where short journeys are concerned. Or they should thus be pleasantly associated with writing or study if the objective is to make these more fortunate.

And if at the same time there is a progressed aspect to the ruler of the third there is also some harmonious progressed aspect operative in the chart, it is good practice to tune in on its vibrations, by thinking of the things and holding the mood characteristic of it, and thus employing it as a harmonious Rallying Force. And it will be more effective if this mood is deliberately held while thinking of short journeys, or writing, or study, or whatever third house events it is intended should be improved in fortune.
