Two things are made plain by these tables: One is that people marry only when both have a progressed aspect to the ruler of the seventh house to give the thought-cells thus mapped more than their ordinary extra-physical power. The other is that there is no planet of marriage. When there is a progressed aspect to the ruler of the seventh, a progressed aspect to Venus favors marriage. What the tables do not show is that in a woman's chart a progressed aspect to Mars, stimulating amativeness, tends even more toward marriage than a progressed aspect to Venus. The endocrine glands of man usually are active enough without the necessity of a progressed aspect to Mars to stimulate their secretions. But many people marry when there is no progressed aspect to Venus and no progressed aspect to Mars operative.

However, as most people only marry once, and yet at various times in their lives have a powerful progressed aspect to the ruler of the seventh, it is evident that seventh house thought-cell activity, apart from proper conditioning and proper environment, does not predispose to marriage. Instead, the event attracted may relate to a non-marital partnership, to a lawsuit, to open enemies

or competitors, or to contacts with the public.

These seventh-house thought-cells that desire and work for marriage were organized by the soul's experiences in lower forms of life. Practically all creatures in the evolutionary scale more complex than those which reproduce merely through simple cell division, at times seek a temporary or more permanent association with the opposite sex. The methods by which fertilization is accomplished are widely varied. They may be a remote association, as when pollen is carried by the wind or insect from the male to the female blossom, or as when certain male fish pass over the beds of eggs previously deposted by the female and cloud the water with the impregnating milt. On the other hand, they may be accompanied by a close companionship during a portion of the year in which, as is common with birds and many

mammals, both male and female work in close co-operation and make great sacrifices, each for the other, in the interest of the offspring. And some creatures, such as the eagle, some ants, the lion, the ostrich and the beaver, mate for life. And all such experiences with partnerships in its evolutionary past have built into the soul the thought-cells which are mapped in the birth-chart of man by the seventh house.

But partnership, whether in marriage or out of it, is not of necessity associated with affection. Affection may be felt where the matrimonial partner is concerned; but it may also be felt for relatives, for friends, for a sweetheart, or for children. But regardless of the object that calls it forth, its energies build thought-elements into the thought-cells mapped by the planet Venus.

It must not be overlooked that in many marriages the most powerful motive is not love. While love may or may not be present, rather frequently a stronger motive, or at least an accessory motive, may be found in the desire for companionship, for a home, for financial security, for children, for social prestige, or for business advantages.

Partners often are of the same sex. But the experiences in the soul's evolutionary past with the opposite sex have chiefly built their thought-elements into the thought-cells mapped by the Sun in the chart of a woman, and into the thought-cells mapped by the Moon in the chart of a man. This means that the importance of the male sex in general in the life of a woman is indicated by the prominence of the Sun in her chart, and how fortunately or unfortunately they tend to affect her life is indicated by the aspects of the Sun. And it means that the importance of the female sex in general in the life of a man is indicated by the prominence of the Moon in his chart, and how fortunately or unfortunately they tend to affect his life is indicated by the aspects of the Moon.

Now in order that marriage—which thus is influenced not only by the desires of the seventh-house thought-cells, but also by the desires of the thought-cells mapped by the opposite sex planet, and in so far as affection is concerned by the thought-cells mapped by Venus—may not be confused with fifth house activities, it should be pointed out that amative relations, in marriage or out of it, as well as pleasures, entertainment, and matters relating to the offspring, are mapped by the fifth house thought-cells.

When these tables were first compiled in 1929 one of the 215

charts did not have a progressed aspect to the ruler of the seventh at the time of marriage. But when Pluto was discovered the following year, and placed in it, it was found this chart also had a progressed aspect to the ruler of the seventh. Marriage, however, does not require that the progressed aspect to the ruler of the seventh shall be harmonious. Nor is there often any difference between the progressed aspects that to an unmarried person bring marriage, and those that to a married person bring divorce. As will be observed by consulting the analysis of the progressed aspects at the time divorce takes place, at the time of this event there must be a progressed aspect to the ruler of the seventh and a progressed aspect to the ruler of the ninth. But in marriage also the legal action, including the performing of the marriage ceremony by a representative of the law or church, nearly always coincides with a progressed aspect to the ruler of the ninth.

Court action to dissolve the marriage tie requires that the thought-cells relating to law and the court gain sufficient extra physical power through a progressed aspect to the ruler of the ninth. And any event of importance affecting the seventh house, whether it be marriage, divorce, a law suit or partnership requires that the thought-cells mapped by this house should gain new extra-physical power.

Not only so, but because of the birth-chart harmony of the seventh house thought-cells, the Venus thought-cells, and the thought-cells relating to the opposite sex, the progressed aspects which bring to one person a satisfactory and permanent marriage, if they occur in another person's chart who is already married, may bring divorce. This other person may have the three mentioned sets of thought-cells so discordant that he can get along with no one, and almost any progressed aspect which gives unusual extra-physical power to the thought-cells mapped by the seventh house and those mapped by the ninth house, if he has previously married, will bring divorce.

Nor does an analysis of the type of progressed aspects present at the time of marriage—100 of which ended in permanent separation or divorce, but a reasonable number of which were considered highly successful as well as permanent—of these 215 persons, reveal any particular aspect as outstanding. The semi-sextile took first place, then came the conjunction, to be followed by the sextile and the trine. The square and opposition were low, but they occured about half as often as the sextile and the trine.

Precautionary Actions—When a progressed aspect to the ruler

of the seventh, together with the conditioning and environment—of which the age forms a part—shows a predisposition to marriage, the first thing is to bear in mind the significance of the tables in this book under the heading, Divorce. Out of 100 marriages that ended in permanent separation or legal divorce, at the time of marriage 79 of them had discordant progressed aspects dominant, and only 3 of them had harmonious progressed aspects dominant. The remaining 18 had harmonious and discordant progressed aspects at the time rather evenly balanced. In 52 of them the only progressed aspect to the ruler of the seventh was discordant, while in but 17 the only progressed aspect to the ruler of the seventh was harmonious.

Quite a percentage of these people who divorced, later remarried when their progressed aspects were harmonious, and made a success of the later marriage. Therefore one of the most important precautionary actions for a successful marriage is that those entering wedlock shall have, at the time, harmonious progressed aspects strong enough to act as Rallying Forces, and a harmonious progressed aspect to the ruler of the seventh. It is perhaps too much to ask in addition that Venus and the ruler of the opposite sex shall not be afflicted at the time by progressed aspect; but the more of these four factors are harmonious the better.

The second precautionary action is to pick a time for the wedding when the aspects in the sky are harmonious. The moment the concluding words, "I now pronounce you man and wife," or its equivalent, are uttered by the proper legal authority, is the birth-time of the marriage. The chart erected for this moment will indicate much of the fortune of the marriage partnership then born. Consequently, this important time should not be left to chance, but should be selected for its outstanding astrological harmony. And as it is a seventh house event, the chart "elected" for the marriage should have as harmonious a seventh house as possible, and as many other harmonious features as can also be found during the period within which it is practical for the marriage to take place.

It is highly unlikely that if these two astrological factors are observed that those entering wedlock will be badly unsuited. But by the time thoughts of marriage begin to be considered, serious thought should have been given to the harmony, or discord, between not only the charts, but also between the way the two have been conditioned since birth.

Marriage is a physical union, and if the electromagnetic forces are of too divergent types they will not fuse but will recoil each from the other. In determining the electromagnetic polarity the Ascendant, which is the ground wire over which the electrical energy reaches the outside world, is important, as are planets in the first house, for these have access to the ground wire. Yet this energy which commonly is known as personal magnetism is not a simple force, but powerfully influenced by the quality of the signs occupied by Sun and Moon and the planets aspecting them; to which the vibratory rates of the Ascendant and planets in the first house are added.

Fiery signs and fiery planets do not blend with watery signs and watery planets, but if the Sun in one chart is in a fiery sign and the Moon or Ascendant of another is in a fiery sign, the magnetisms may tend to fuse pleasantly. Such vibrations as are indicated by Aries united to Cancer, Capricorn united to Gemini, or Taurus united to Leo, however, unless there are other sympathetic points of contact, tend to jar upon each other.

But in addition to physical harmony, husband and wife should have at least some interests in common. A husband who cares only for business and baseball games, and a wife who cares only for literature and social affairs, afford little companionship for each other.

Not only should their mental interests be not too divergent, but their spiritual leanings should have some harmony. If one is a materialist, caring only for riotous living, and the other is deeply religious, with a yearning to live a spiritual life, this spiritual divergency will prove a source of discord.

The astrological factors that must be considered to ascertain the points of harmony and the points of discord between two people are quite complex, and when people find themselves in love they are not apt to seek out and be governed by a cold astrological analysis of the situation. Therefore, that the thought-cells may desire, and work for, marriage with someone harmonious, these desires should be reconditioned beforehand to be more harmonious. Such reconditioning not only will assist in getting the right mate, but will also assist in making the marriage happy and successful after it takes place.

The constructive thoughts of the planet ruling the seventh house should be pleasantly associated with thoughts of marriage and thoughts about other people in general. Not only the ability to get along well with the marriage partner, but the general ability to get along well with other people requires harmonious seventh house thought-cells. Whenever thoughts about the antagonism of others, or thoughts which are antagonistic to others begin to edge into the consciousness, these should be displaced with pleasant thoughts relative to other people, or relative to the future marriage partner, using either the constructive thoughts of the type ruled by the planet governing the seventh house, or the constructive thoughts of its mental antidote.

The thought-cells whose desires and activities determine the influence of the opposite sex on the life may also be treated pleasantly with constructive thoughts of its own type, or with those of its mental antidote. This will assist to bring better fortune where the opposite sex in general, including the future

partner, is concerned.

And to make affectional matters more fortunate, including those that are related to marriage, every time thoughts relating to affection start unpleasant emotions, something pleasant should be brought to mind relating to the affections. And a bit of Saturn caution may be used to see to it that one is not too often placed in a position where affectional relations are concerned that gives rise to discordant emotions.

Whether or not an individual can gain money during a certain period, and whether at that time it can be acquired from a given venture, are important considerations which can be determined neither from the progressed aspects to the ruler of the second house alone, nor from the progressed aspects as a whole which are then operative.

The normal ability of the individual to make money is determined by the activity and harmony of six different groups of thought-cells: First in importance are those mapped by the second house, next in importance are those mapped by the business planets, Jupiter and Saturn, then come those mapped by the tenth house, and finally those mapped by the Sun and Moon.

In considering the possibility of financial gain from some special source or venture, however, the normal ability to gain from that source, as indicated by the birth-chart, must be given special consideration. If through business, the harmony and activity of the tenth house thought-cells are specially important; if through speculation, the activity and harmony of the fifth house thought-cells must be considered; if it has to do with the preparation and serving of foods, due attention should be given the sixth house thought-cells; or if it relates to following a given vocation attention should be given to *The Luck Factor* relative to that vocation as set forth in the book, HOW TO SELECT A VOCATION.

Making money at a certain time is not merely the result of progressed aspects. It is chiefly determined by the amount of extra-physical power which special groups of thought-cells acquire, and the desires they have at that time. If these thought-cells normally have a strong desire to repel money, as shown by heavy discords in the chart of birth, it may be that no amount of harmonious energy added by progressed aspects can change them sufficiently to give them desires to demonstrate financial gain. On the other hand, if these groups of thought-cells normally have a strong desire for money, as indicated by harmonious aspects in the birth-chart, it may be that any progressed aspect energy added to them will be unable to cause them to desire financial loss, in which case the individual will make some gain even under progressed afflictions.

Nevertheless, the table reveals one thing unmistakably: That the other thought-cells, however well intentioned they may be, are powerless to demonstrate money in more than normal amounts, except during such periods as the second house thoughtcells gain unusual activity through the energy afforded them by

a progressed aspect to the ruler of the second.

In reference to those who make money when all the progressed aspects are discordant, it is interesting to note that the winners of lotteries, sweepstakes and guessing contests, as often as not have a heavy progressed affliction to the ruler of the fifth house, and may have no harmonious progressed aspects at the time. In the unexpected winning of fantastic amounts, a progressed affliction to Neptune often plays an important part, especially when the ruler of the fifth house. Yet the basic power and trend of the thought-cells to attract such unusual fortune is shown in the chart of birth.

In considering the 24% of people who gain money when the only progressed aspect to the ruler of the second is discordant, and the 24% who gain when of the total progressed aspects present those discordant are predominant, it must be remembered that some of these gains in money were at the expense of severe loss in other ways, as when the gain came through inheritance due to the death of a loved one.

Yet other than the normal desires of the thought-cells to demonstrate money, as mapped by the chart of birth, probably the most significant things revealed by the tables is that it is of more importance to have powerful harmonious progressed aspects operative at the time than merely to have a harmonious progressed aspect to the ruler of the second; and better to have other dominantly harmonious progressed aspects at the same time the ruler of the second is somewhat afflicted by progression, than to have other dominantly discordant progressed aspects at the same time the ruler of the second receives a harmonious aspect by progression.

This means that when heavy progressed aspects are present it is customary for people to permit them to dominate their thoughts and feelings to the extent they become Rallying Forces, and feed their type and harmony or discord of energy to all the thought-cells reached by any progressed aspects then operative, and thus become more important in determining the harmony or discord of the desires of the thought-cells mapped by a house, than is the less powerful energy afforded these same thought-cells by

the aspect to the ruler of the house.

In addition to the desires of these thought-cells relating to money, perhaps we should also consider that many kinds of ventures, including such acquisition of money, are so dependent upon the good-will, trustworthiness and ability of other people, and upon a variety of circumstances that contribute directly or indirectly to success, that even when the thought-cells relative to the venture work somewhat adversely from the inner plane, if the other groups of thought-cells that relate to these factors are active enough demonstrating the harmonious conditions they desire, success may be brought by these accessory influences. On the other hand, even when the thought-cells relative to the venture are trying to demonstrate success, if other groups of thought-cells are demonstrating discords in the departments of life to which they relate, these may contribute hindrances of sufficient power to more than counteract the favorable extraphysical power of the thought-cells working for the matter's success.

From a progressed aspect to Jupiter money cannot be expected unless at the same time there is a progressed aspect to the ruler of the second house. But if there is a second house progressed aspect, the influence of Jupiter increases the tendency for the event to involve money. The other factors relating to the possibility of making money at a given time seem to be covered by the following five steps:

1. Any progressed aspect to the ruler of the second should be considered as giving extra-physical power to the money thought-cells. Consider the birth-chart harmony and discord of these planets as well as the harmoney or discord of the progressed aspect, and thus count the progression as strongly or weakly favorable or unfavorable.

- 2. A careful estimate should be made from the birth-chart of the individual's ability to attract money, especial attention being given to his ability to attract it through the contemplated venture.
- 3. Consider any progressed aspect to the ruler of the house through which the money is expected to come—business, speculation, real estate, inheritance, friends, etc.—as weakly or strongly favorable or unfavorable.
- 4. Consider whether or not, and to what extent, the total progressed aspects at the time are predominantly harmonious or discordant; not neglecting to consider how these progressed aspects are influenced by the birth-chart aspects of the planets involved.
- 5. Give due weight both to the previous conditioning of the individual and the present environment as influencing money making possibilities.

A judicious balancing of these five factors should reveal

whether or not the conditions favor making money during the interval considered. Yet it must not be overlooked that through precautionary actions it is possible to make money at times that would show only loss unless such intelligent actions based on

knowledge of astrology had been taken.

Precautionary Actions—Of primary importance in making money, and having better success with finances in general, is to give the second house thought-cells more harmonious desires in that direction. This can be accomplished by selecting trains of constructive thoughts belonging to the planet ruling the second, and associating these as often as possible, and as pleasantly as possible, with all thought about finances. If the second house ruler is too heavily afflicted to make it feasible to think its constructive thoughts with enjoyment, the constructive thoughts ruled by the planet which is its mental antidote should frequently, and with emotional intensity, be pleasantly associated with thoughts about finances. And these harmonious and constructive thoughts should be quickly substituted whenever money worries start to enter the mind.

The Jupiter and Saturn thought-cells, the tenth house thought-cells, and the thought-cells mapped by Sun and Moon also, to the extent feasible, should be reconditioned more harmoniously.

Furthermore, if during the time a progressed aspect forms to the ruler of the second there is also some harmonious progressed aspect operative, it should be tuned in on and used as a Rallying Force. Get into the mood of its harmonious vibrations. And it will be more effective if this mood is held while thinking about financial matters.

These tables in which the progressed aspects are classified at the time financial losses occured are a clear demonstration that if the birth-chart desires of a group of thought-cells are discordant enough, sufficient harmony commonly is not given them by a harmonious progressed aspect to make them work for things advantageous to the individual. Not only in 12% of these losses were the only progressed aspects to the ruler of the second harmonious; but in 7% of them the individual suffered financial loss when the total progressed aspects, from which Rallying Forces often are derived, were more harmonious than discordant.

A significant factor which the tables do not reveal, however, is that in each of these instances in which harmonious progressed aspects are dominant, these harmonious progressed aspects are to planets strongly discordant in the chart of birth. This means that if a group of thought-cells is mapped in the birth-chart by heavy afflictions, that their basic desires are so strongly set on demonstrating that which is unfavorable to the individual, that the new and abundant harmonious energy furnished them by a trine aspect through progression enables them to become powerfully active, but is unsuccessful in changing the trend of their desires sufficiently that they work to demonstrate an event which is completely beneficial to the individual.

It is a most important thing to know, not only in reference to making or losing money, but relative to the predisposition toward events affecting each of the twelve departments of life, just how much dependence can be placed on a progressed aspect to change the trend of the desires of the thought-cells from their basic, or birth-chart, tendency toward harmony or discord. One of the difficulties encountered in this problem is that usually in a birth-chart a planet has several aspects, and therefore it is not possible clearly to know just how much of its fortunate or unfortunate trend is due to any one of these birth-chart aspects. And an equal difficulty arises in considering the influence of progressed aspects; for while there may be but a single progressed aspect to the planet whose influence is being weighed, there usually are progressed aspects to other planets which operate as

Rallying Forces, and thus make the precise estimation of the influence of any single progressed aspect a very complex matter.

If it were possible to weigh—apart from other aspects, apart from special variations in environmental resistance, apart from conditioning, and apart from precautionary actions based on astrological knowledge—a birth-chart aspect against a progressed aspect of the same power, but of opposite harmony or discord, such research as we have done indicates that the resulting event would be about 50-50 in its fortune or misfortune to the individual. That is, in so far as we have been able to gather and use data suitable for such comparison, it seems that a progressed aspect of equal power is able to change the trend so far as harmony or discord is concerned, of a birth-chart aspect, temporarily by about 50%.

This does not signify, however, that a progressed harmonious aspect of sufficient intensity, to a birth-chart planet discordantly aspected, just cancels out, and nothing happens. On the contrary, to the extent the planet is powerfully aspected in the birth-chart and prominent by position, and receives powerful progressed aspects, either harmonious or discordant, it is indicated that the thought-cells thus mapped acquire extra-physical power sufficient to enable them to demonstrate events. Thus at such a time events relative to the houses ruled by the planets involved in the progressed aspect are almost certain to come into the life.

Under such circumstances, in which the basic harmony of the thought-cells is given about an equally strong trend toward discord by the progressed aspect, or the basic discord of the thought-cells is given about an equally strong trend toward harmony by the progressed aspect, either both fortunate and unfortunate events are attracted, or the chief event which comes into the life possesses both advantages and disadvantages which are about equal in importance.

In the tables of money losses here presented, it should be brought to notice that in the 7% of charts in which financial loss was coincident with predominantly harmonious progressed aspects, in a majority there was a harmonious progressed aspect to Neptune and this planet heavily afflicted in the chart of birth.

While a progressed aspect to a harmonious birth-chart Neptune frequently is present in the chance winning of fabulous amounts, the general rule is that Neptune seldom delivers all it promises, either good or evil. It exaggerates the appearance of things; and in the instances cited in these tables, the individual reached the verge of some huge financial gain, to have it, through some un-

foreseen circumstance, vanish just before he was able to grasp it.

The inevitable conclusion reached from a study of the birthcharts of those who have made vast amounts of money, is that the very active thought-cells within their souls bearing upon money, as mapped in their birth-charts, have become progres-

sively more harmoniously conditioned.

A favorable progressed aspect, together with initiative and intelligence, has enabled the individual to make some gain. Then this experience has laid the foundation for greater and greater confidence in ability to gain money, and satisfaction in its acquisition. The money demonstrating thought-cells, as the result of his mental attitude toward his experiences with money, as a snowball rolling down hill gathers more and more snow, have gained progressively both in their desire to attract money,

and in their extra-physical power to do so.

Losses and difficulties did occur when discordant progressed aspects formed to afflicted birth-chart planets, but the gains at those times when progressed aspects were favorable, or when they formed to planets well aspected in the birth-chart, were sufficiently large to enable huge fortunes to be piled up. In other words, a study of the lives and the progressed aspects of those individuals who have amassed great fortunes, indicate that in addition to having birth-charts favorable to such acquisition, they have also, unwittingly, early started to recondition their thought-cells after the manner recommended in this book under the heading, precautionary actions.

Precautionary Actions—When the progressed aspects foreshow a period in which there is a predisposition toward financial loss, the first step should be to use as much intelligence as possible to cause environmental resistance to such loss. This means that financial hazards of all kinds should be avoided, and the individual should so situate himself, and so conduct himself, that

such loss is as much precluded as possible.

But in addition to this—as the loss, if it occurs, will be chiefly due to the activities of certain groups of thought-cells within his finer form—he should take steps to recondition the desires, and make them more harmonious, of the thought-cells that

are apt to affect money matters.

He should select trains of constructive thoughts which are the expression of the planet ruling his second house, and should associate these as often as possible, and as pleasantly as possible, with thought about money. If the second house ruler is too greatly afflicted to think such thoughts pleasantly, the constructive thoughts which are the expression of the mental antidote should be used instead, and these should be held with emotional intensity, and be pleasantly associated with all thoughts about money. And these harmonious and constructive thoughts should be used to crowd from the mind thoughts of financial loss, or other disagreeable thoughts about money.

The Jupiter and Saturn thought-cells, the tenth house thought-cells, and the thought-cells mapped by Sun and Moon also, to the extent feasible, should be reconditioned more harmoniously. And if, during the time the progressed aspects predisposing toward money loss are present, there is also some harmonious progressed aspect operative, it should be tuned in on through thinking thoughts characteristic of it, and holding the mood of its vibrations. And it will be more effective if this mood is held while thinking about money.

Here again we have tables indicating that death affects the life of an individual significantly only when there is a progressed aspect to the ruler of his eighth house. And while it is true that when elderly people affect the life in any way there frequently is a progressed aspect to Saturn, this planet is not involved in the death of the mother often enough that any reliance can thus be placed on its aspects.

We can, however, be sure that each time the mother impor-

tantly affects the life, the individual will have a progressed aspect to the ruler of the tenth. Yet progressed aspects giving the tenth house thought-cells greater activity may affect the life through business or something relating to the honor, instead

of through the mother.

It should be noted also, as demonstrated by the progressed aspects in the charts of those who have a foster mother or a step-mother, that when such a relationship exists these affect the life importantly only when there is a progressed aspect to the ruler of the tenth. In other words, they come under the influence of the same group of thought-cells as does the blood mother.

Apart from consulting the birth-chart and progressed aspects of the mother, foster mother or step-mother, it is quite difficult to ascertain whether progressed aspects to the tenth and the eighth indicate a predisposition for this person to die, or whether it will affect the business and the collection of debts. The money due an individual from others is ruled by the eighth house, and if such money is owing, a progressed aspect to the eighth is quite likely to affect the debt. Thus an affliction to the eighth may indicate that a debt will be lost through the debtor dying, going into bankruptcy, or moving to an unknown destination. And a progressed aspect to the tenth may indicate some separate transaction affecting the business, or that the business will be affected by failure to collect this debt.

Thus to decide that there is a predisposition during a given period for the mother to die, in addition to the individual's chart, the mother's chart should be consulted, and how she is apt to be affected by progressed aspects under the environmental

conditions surrounding her.

Precautionary Actions—When from a consideration of these various factors it is believed that the progressed aspects indicate a predisposition toward the death of the mother, this should not be permitted to give rise to fear, or to cause the death image to be held in the individual's mind. A predisposition is not a certainty. Many times in their lives people have progressed aspects to the ruler of the eighth and progressed aspects to the ruler of the first and do not die, and many times they have progressed aspects to the ruler of the eighth at the same time there are progressed aspects to the ruler of the tenth and the mother does not die.

Above all, the suggestion should not be given the mother that she is likely to die, for either such an oral suggestion, or the image of her death held in the mind of relatives, is potent to work toward bringing death about. Instead, the image of the mother in perfect health should be held by others in full confidence that she will live and enjoy life.

But in addition to this constructive type of mental treatment, she should be prevailed upon, if possible, to recondition her first house thought-cells, and the thought-cells whose discords threaten her, after the manner indicated under the heading, Death of Individual, and to eat the foods indicated for the particular progressed aspects she is under, as set forth in the book, STELLAR DIETETICS.

The individual in whose chart the predisposition is shown toward the loss of his mother should also recondition in a more harmonious manner his tenth house thought-cells and his eighth house thought-cells. He can thus recondition his tenth house thought-cells by selecting trains of thought which are the constructive expression of the planet ruling his tenth house, and associating them pleasantly with thoughts of his mother.

In a general way he can recondition his eighth house thought-cells by selecting trains of thought which are the constructive expression of the planet ruling the eighth, and associating these as pleasantly as possible with thoughts about the money others owe him, or with thoughts about gifts. Or if these trains of thought are too inclined to arouse painful memories, he can use instead the constructive thoughts of the mental antidote of the planet ruling the eighth, and associate these with harmonious enthusiasm with thoughts about receiving gifts, or about money due. But it is better not to give these thought-cells desires relative to death by thinking about death in any way.

People often go through unbelievably powerful discordant progressed aspects without passing to the next plane. Thus even when a child's chart is heavily afflicted by progressed aspects, and there is a progressed aspect to its eighth house and a progressed aspect to its first house, it should not be considered more

than a danger, which precautionary actions should be taken to avoid. And it may be counted on that the child will live if at the same time there is not a progressed aspect to the eighth, and a progressed aspect to the fifth, in the charts of both parents.

Furthermore, the parents may be sure that a child will not cause them important difficulty, through illness or other event, except when there is a progressed aspect to the ruler of the fifth, and at the same time progressed discordant aspects in their charts.

In reference to the events toward which, at different times, due to progressed aspects adding energy to thought-cells mapped by the birth-chart, a child is predisposed, much more can be determined from its chart and progressed aspects than from those of its parents. The fifth house progressed aspects in the chart of a parent may relate to a child, or it may relate instead to some speculative venture, to pleasures, or to entertainment.

Not only so, but it is far easier to condition the thought-cells in the early years of life so that they will express their characteristic planetary energy, not only constructively, but through selected channels. That is, the earlier in life conditioning is commenced the less energy and effort is required to accomplish

a given change.

While the thought-cells at birth have activities characteristic of the planet ruling them, related to the house of the birth-chart which maps them, and broadly fortunate or unfortunate in their desires, they have not as yet been conditioned to express in specific events such as are afforded by a human environment. The thinking, the emotions, and the diet of a child are under considerable degree of control by parents who understand esoteric psychology well enough to know how to get the child to desire those things which they believe to be beneficial to it. When, therefore, as indicated by a progessed aspect to the sixth, a progressed aspect to the first, and heavy progressed afflictions in its birth-chart, a period is foreseen when illness seems likely, not only the mental and emotional processes of the child should be cultivated to prevent this predisposition from becoming a reality, but the diet also should be regulated, according to the instructions given in STELLAR DIETETICS, to the progressed aspects in such a way as to give great resistance to the particular disease that otherwise might develop.
